

Rally Trailer Manufacturing, LLC, warrants your trailer to be free from defects in materials and workmanship to the original purchaser for the time period of 1 (one) year from manufacturers date or the beginning of in-service purchase date, whichever comes first. All hydraulic fittings and parts will carry a 6 (six) month warranty. The trailer warranted hereunder must be operated by the purchaser in accordance with the practice approved by Rally Trailer Manufacturing, LLC, with loads not exceeding the manufacturer's rated capacities and subject to all terms and conditions of this limited warranty. Warranty authorization form must be completed and returned.

What is Covered:

Within the period of this warranty, Rally Trailer Manufacturing, LLC will repair or replace, free of charge, any part providing defective material or workmanship. All warranty repairs and services must be performed and authorized by a Rally Trailer technician and must be authorized by Rally Trailer Manufacturing, LLC. Labor amounts will be determined by Rally Trailer Manufacturing, LLC, not to exceed \$75.00 per hour. It is the final decision of Rally Trailer Manufacturing, LLC to determine the best method of repair.

Warranty Voided:

The following conditions will hereby void the limited 1 (one) year warranty of purchased trailer:

- Accident
- Modifications made to trailer or any other trailer parts
- Improper maintenance to any parts of trailer
- Damage or failure resulting from: A) any misuse including, overloading, improper loading, negligence, alteration, or accidents, B) inadequate maintenance including loose nuts, bolts, screws, or improperly torqued wheel lug nuts,C) use of underrated or incorrect hitch equipment including the hitch ball, pintle, or improper hitching, D) towing a trailer that exceeds the tow vehicle manufacturer's specific towing limitations.
- Negligence
- Misuse of trailer or any of it's components or parts in any way

- Alterations
- Repairs done by purchaser
- Any damage to frame, axles, tires or any other component due to overloading or failure to properly balance load

Warranty Exclusions:

- Normal wear to trailer items including: paint (including chipping, fading, and aging), brakes, tires, bearings, axle seals, light bulbs, and fading or cracking of flooring; but are not limited exclusively to these items
- Deterioration resulting from weather, road conditions or acts of nature
- Inconvenience, loss of trailer use, loss of revenue, rental, or any other loss or expenses incurred to obtain warranty service.
- Overtime labor rates, service calls, towing charges, expediting, freight, or transportation costs.

Any modifications, alterations or repair to any product manufactured by Rally Trailer Manufacturing, LLC without their prior knowledge and consent will void manufacturers warranty.
